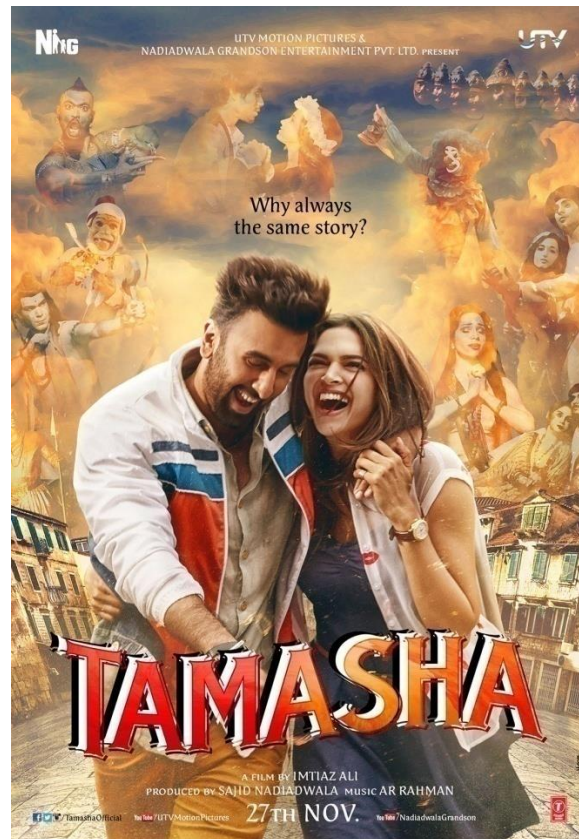

### Laxmii (2020)



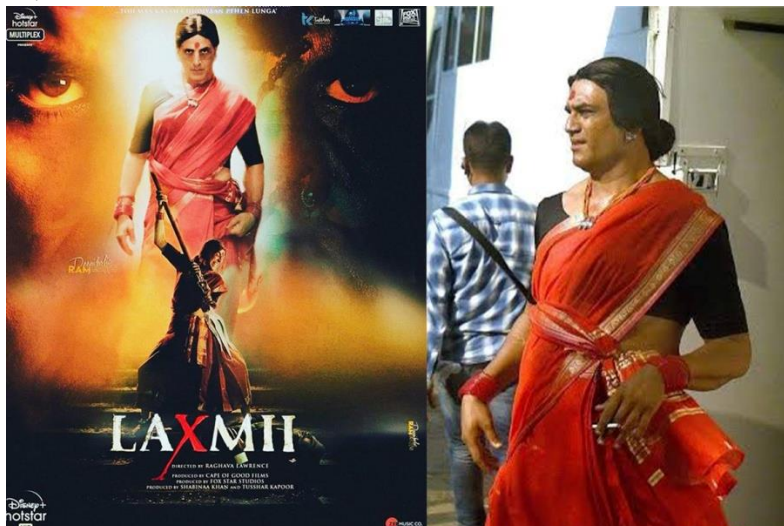

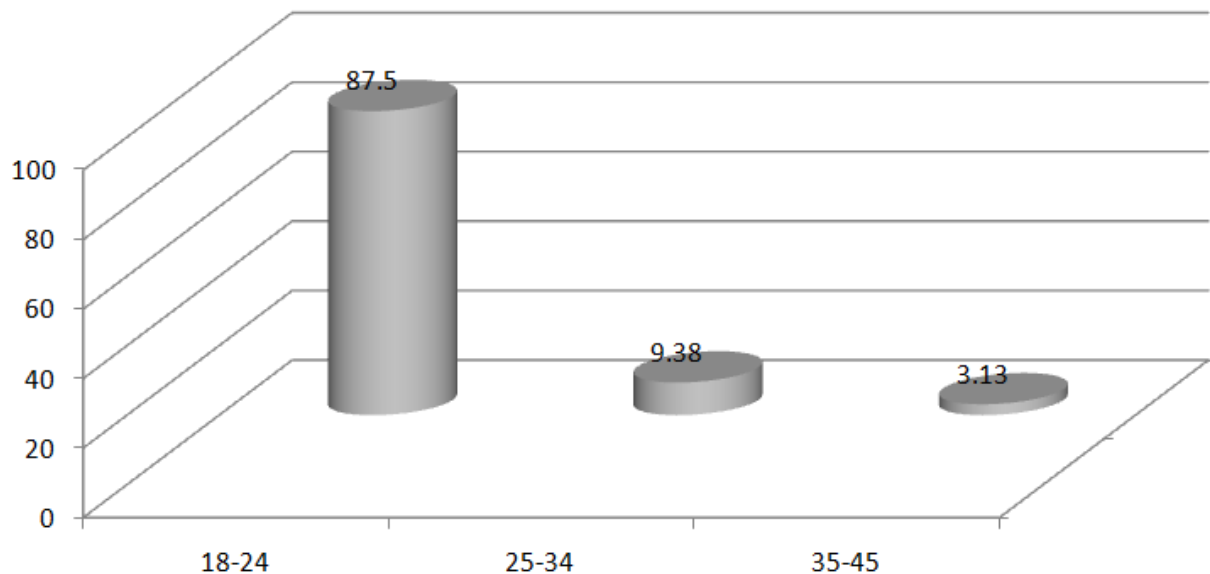

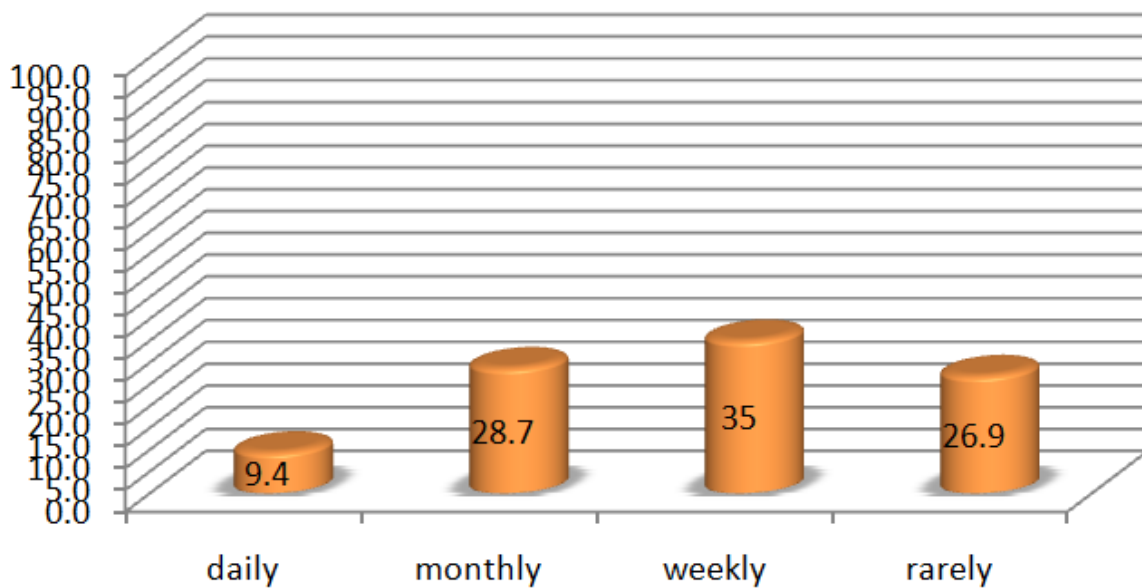

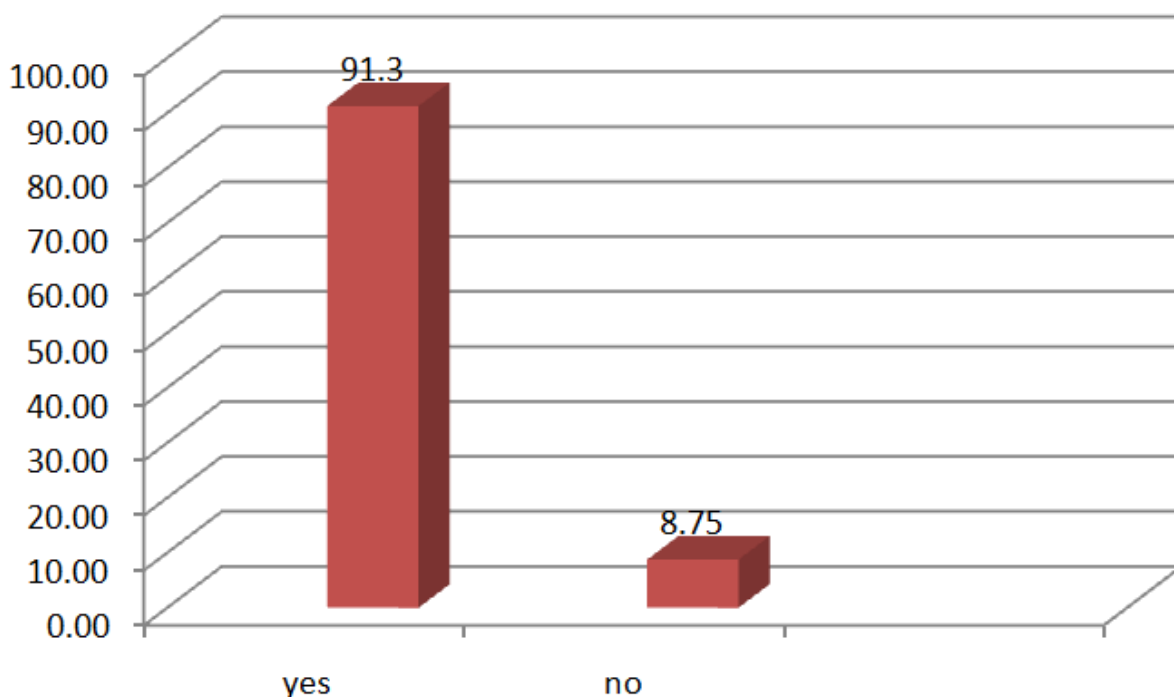

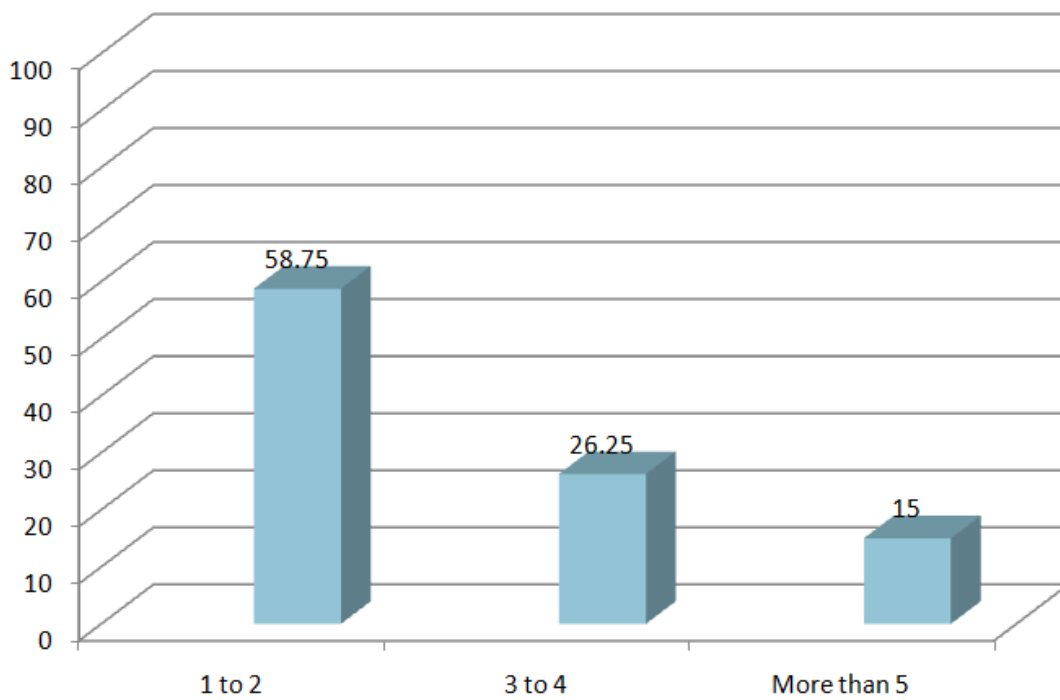

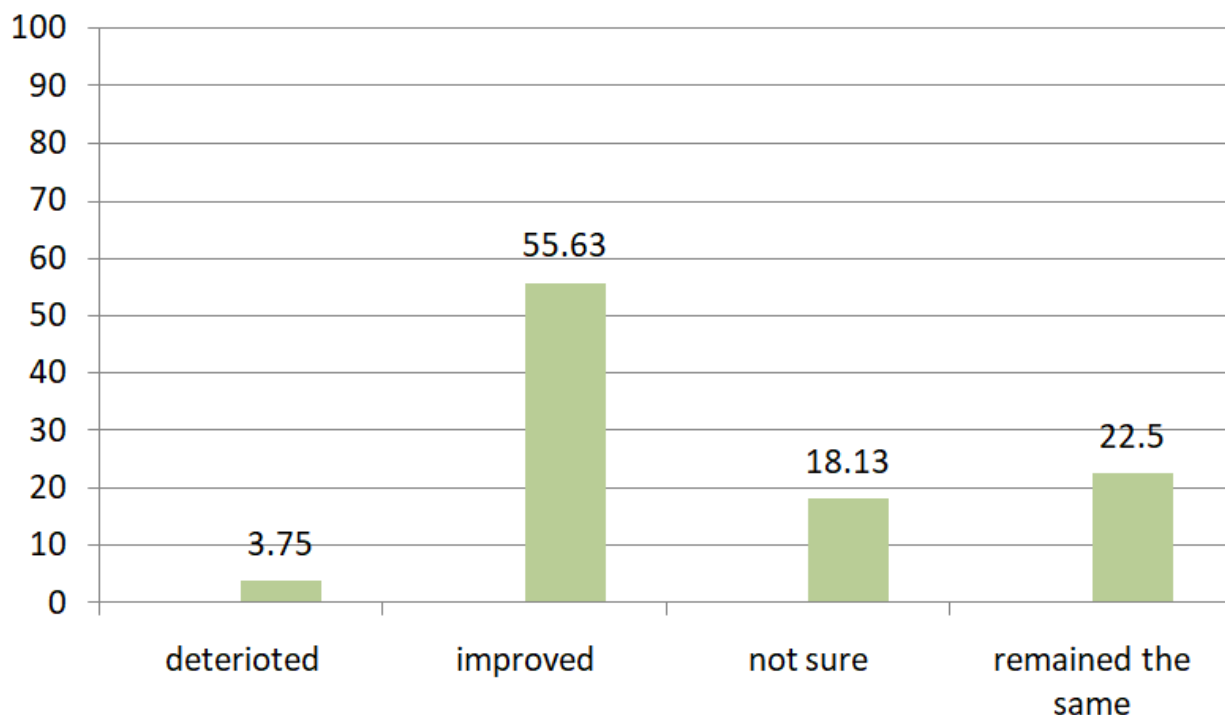

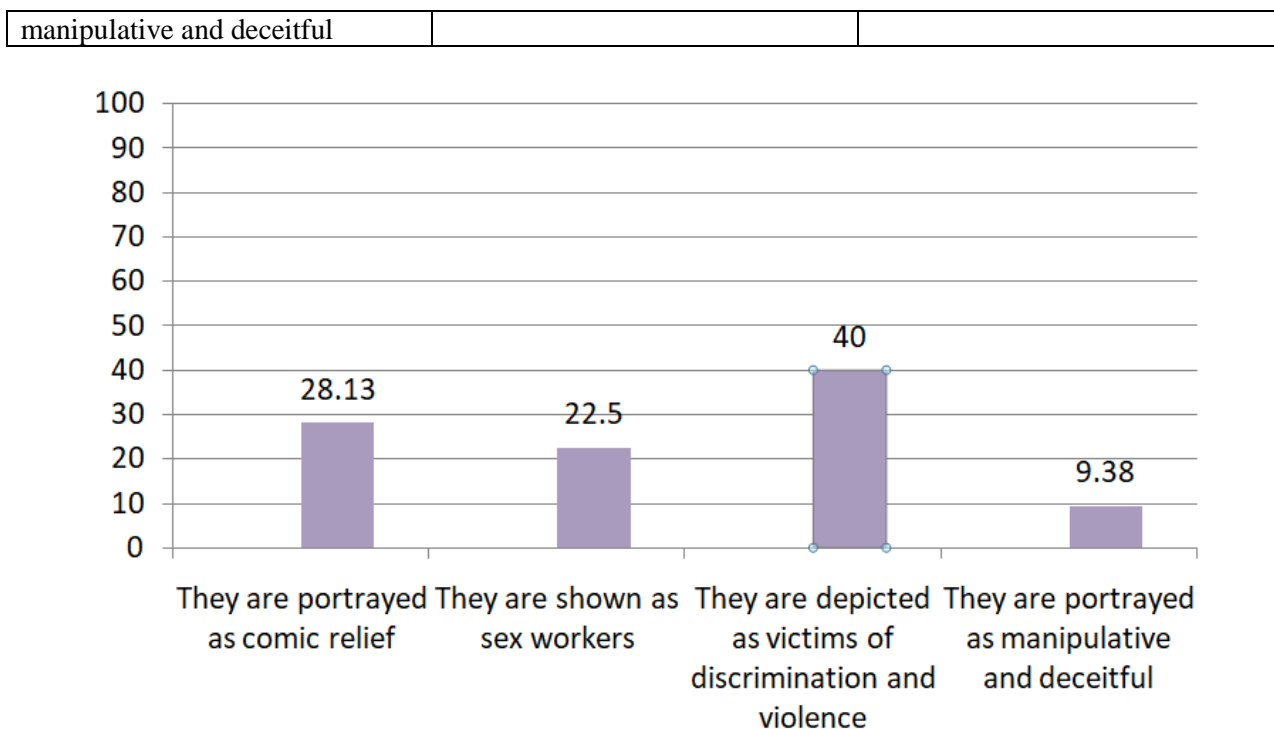

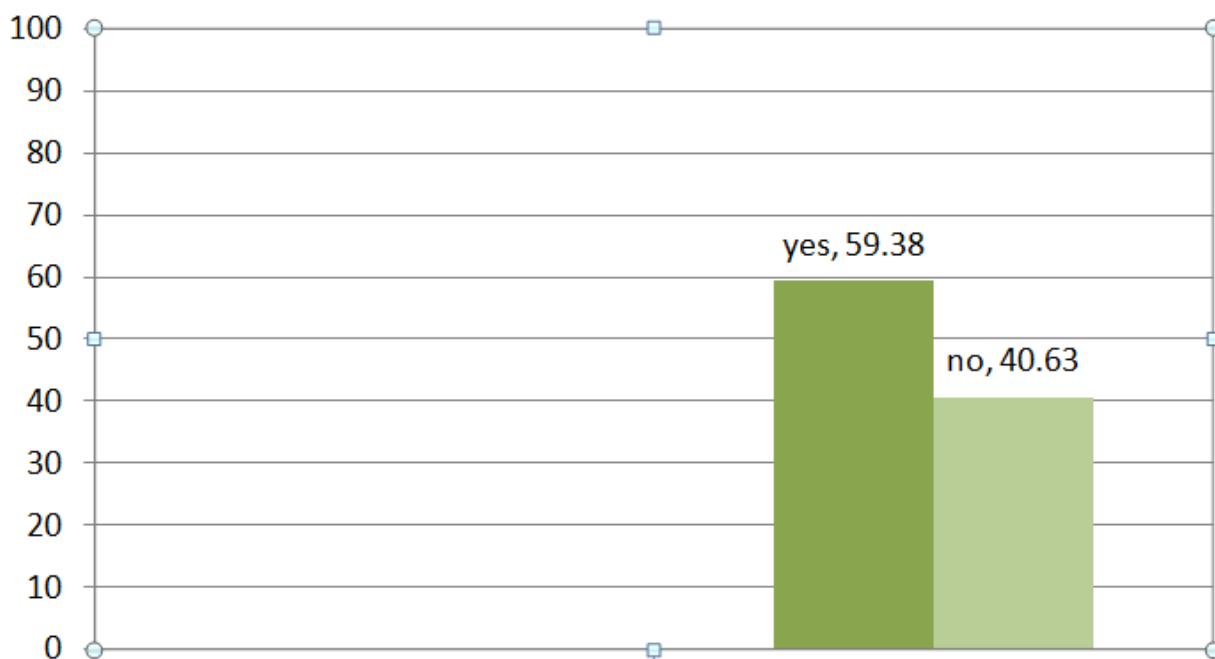

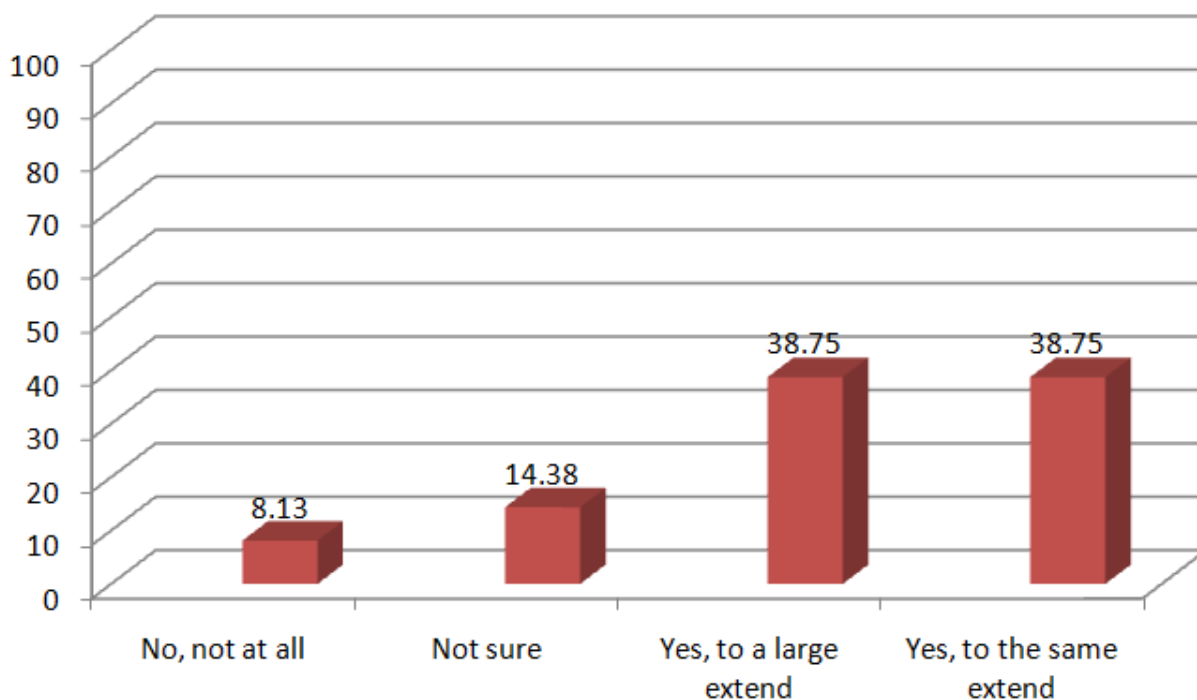

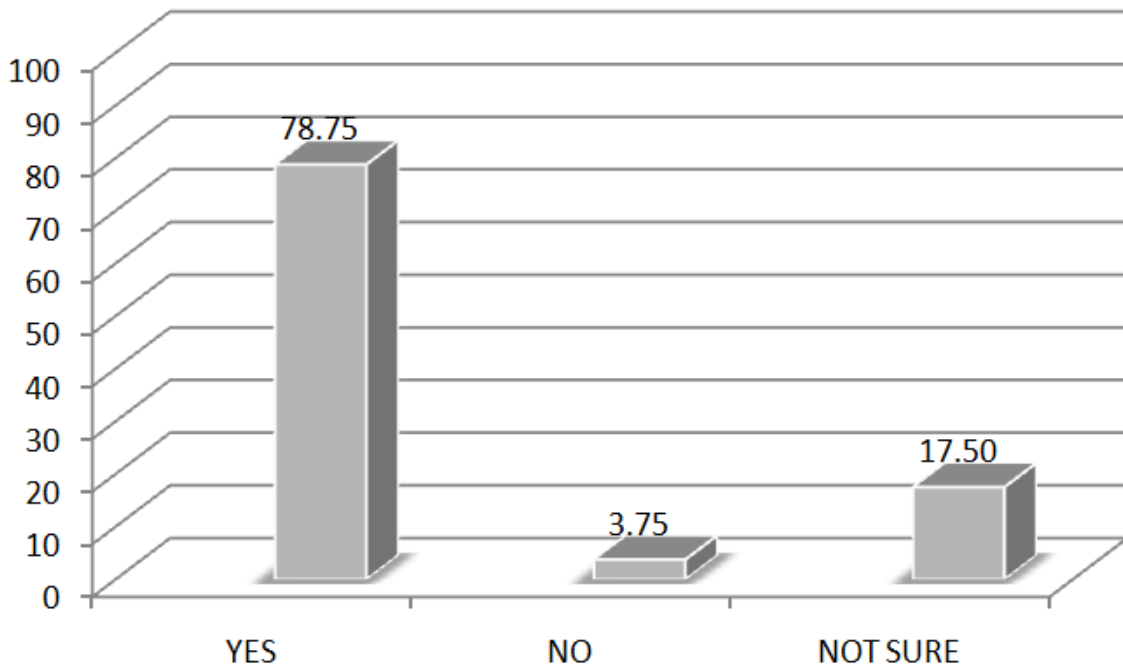

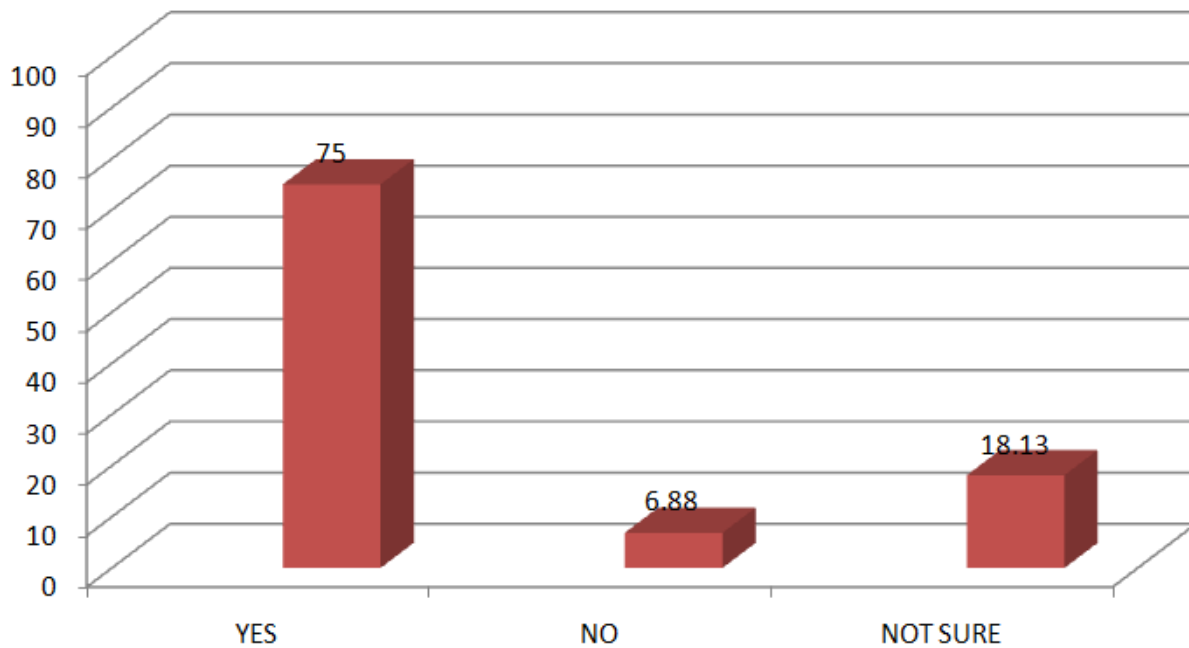

Give transgender characters a positive and empowering role in the movie with confidence, and highlight their contributions to society, such as running a general store, etc.

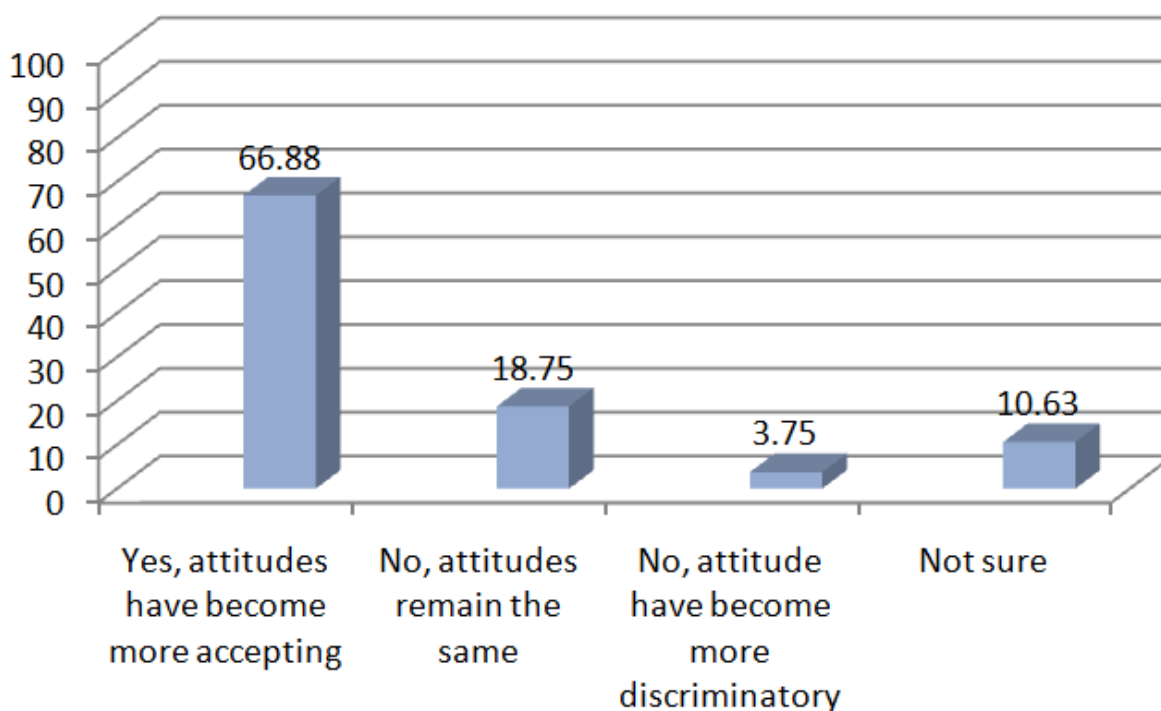

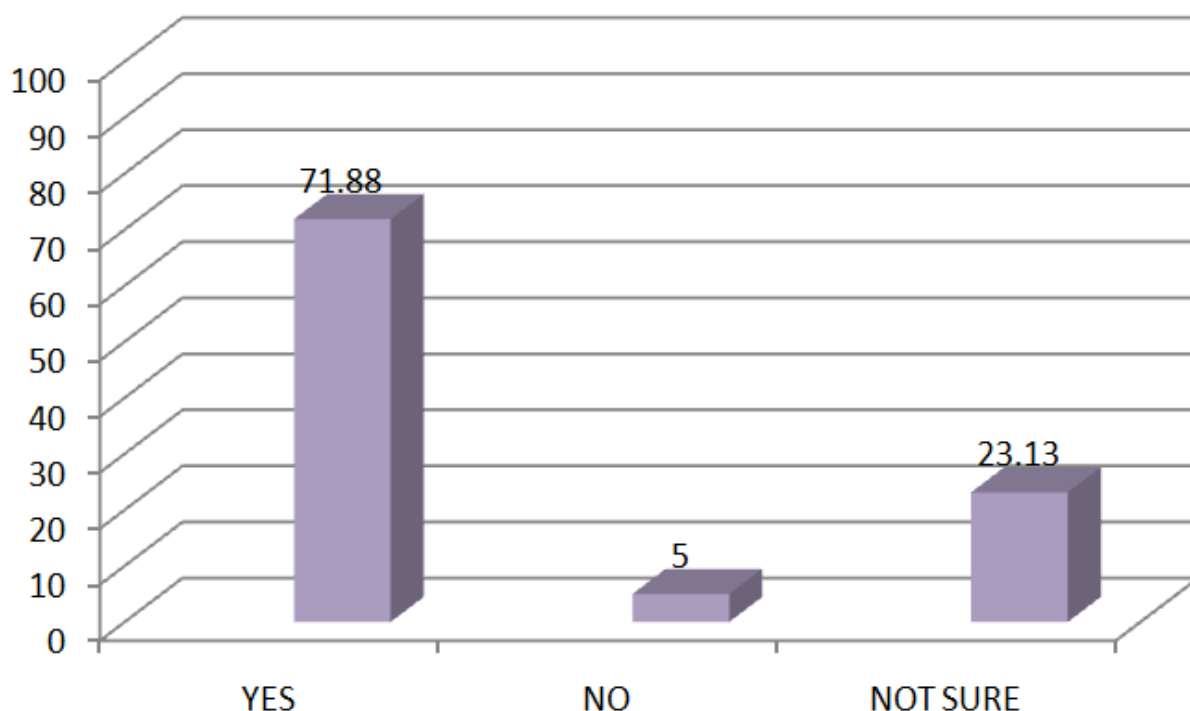

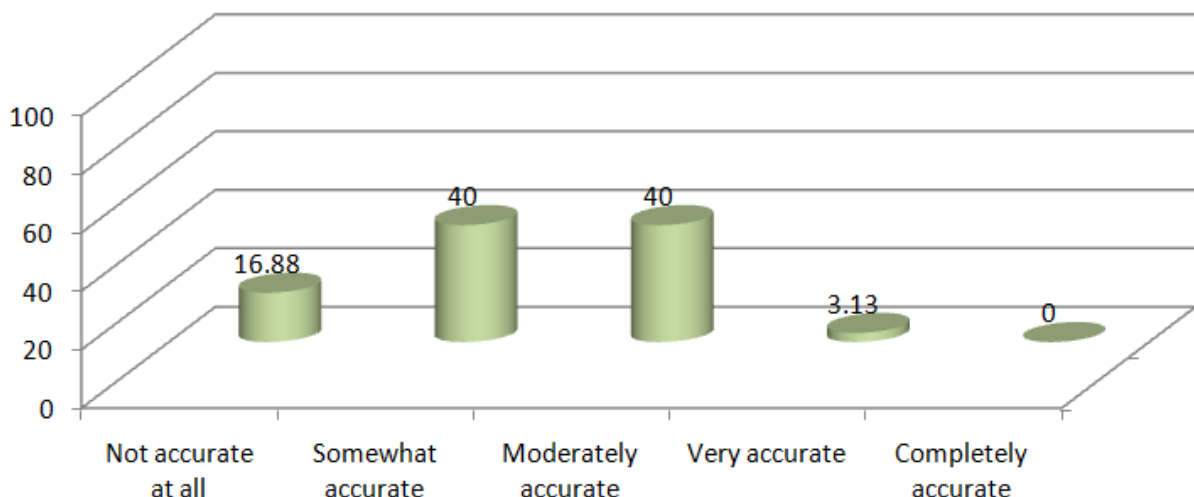

It is also possible that some respondents may be motivated by a curiosity to learn more about transgender issues and to see how they are portrayed in popular media.

Overall, this data highlights the importance of representation in media and suggests that there is a potential market for Bollywood films that feature transgender characters. It is up to filmmakers and producers to take note of this demand and work towards creating more inclusive content that accurately represents diverse communities.

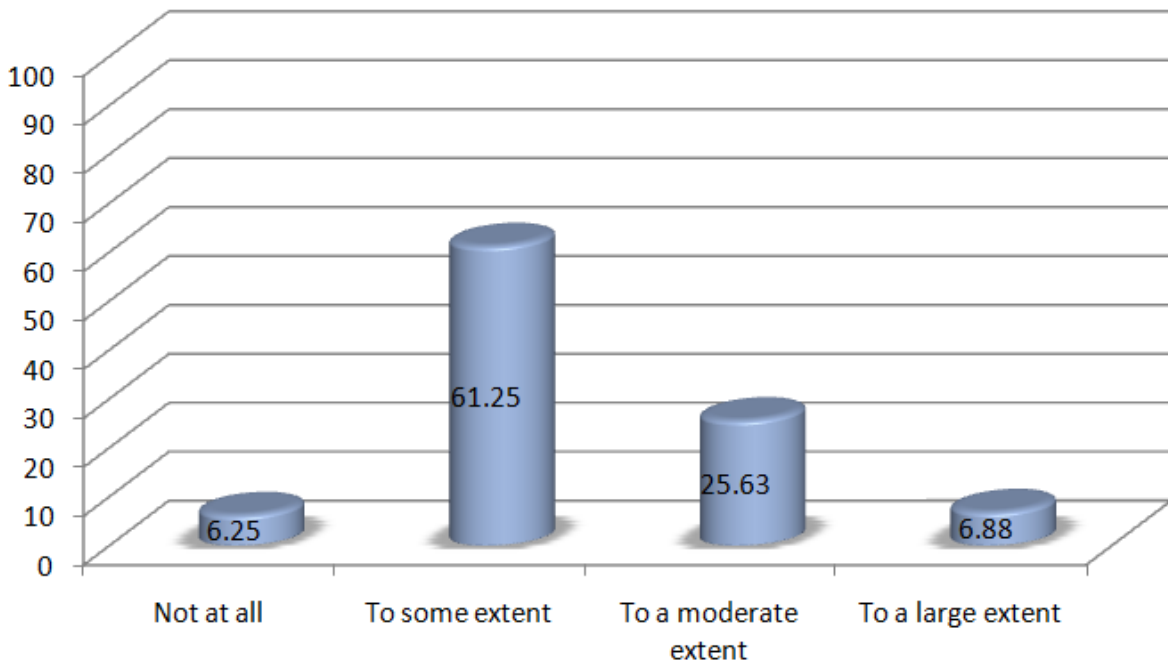

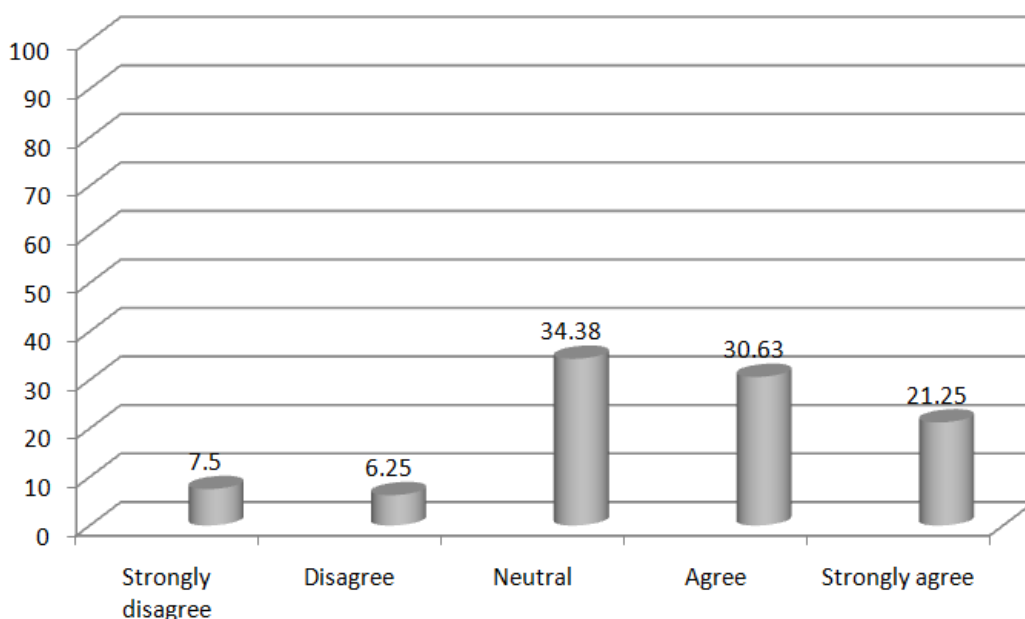

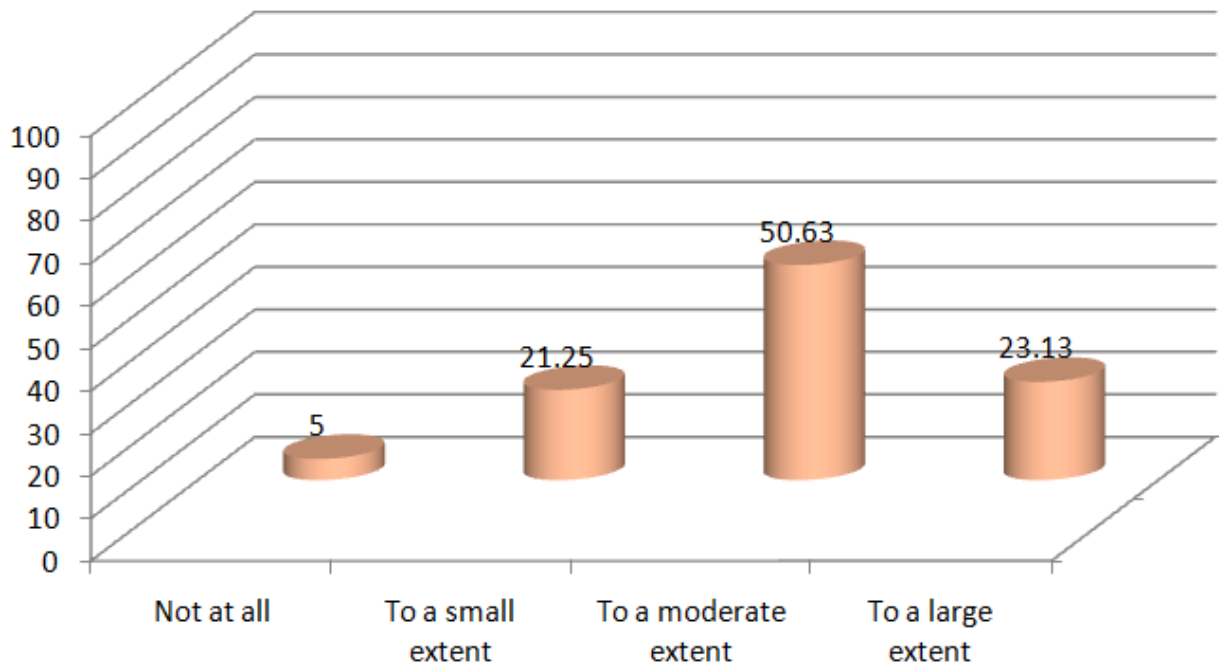

More specifically, 23.1% believe that Bollywood films can contribute to a large extent, 50.6% believe it can contribute to a moderate extent, and 21.3% believe it can contribute to a small extent. Only 5% of the participants believe that Bollywood films cannot contribute at all.

This suggests that many people have faith in the potential of Bollywood films to positively influence attitudes towards transgender individuals in Indian society. However, it is important to note that the impact of films on social attitudes and behavior is complex and multifaceted, and should not be seen as a panacea for societal problems. Other factors such as education, social support, and policy change are also important in promoting acceptance and reducing stigma towards marginalized communities.

The data suggests that a majority of respondents believe that Bollywood films can contribute to promoting acceptance of transgender individuals in Indian society to some extent. This is a positive sign, as media representation can play an important role in shaping societal attitudes towards marginalized groups.

However, it is also important to note that a significant percentage of respondents feel that Bollywood films can only contribute to a small extent, or not at all. This highlights the need for more nuanced and accurate representation of transgender individuals in media, and for Bollywood to move away from harmful stereotypes and tropes.

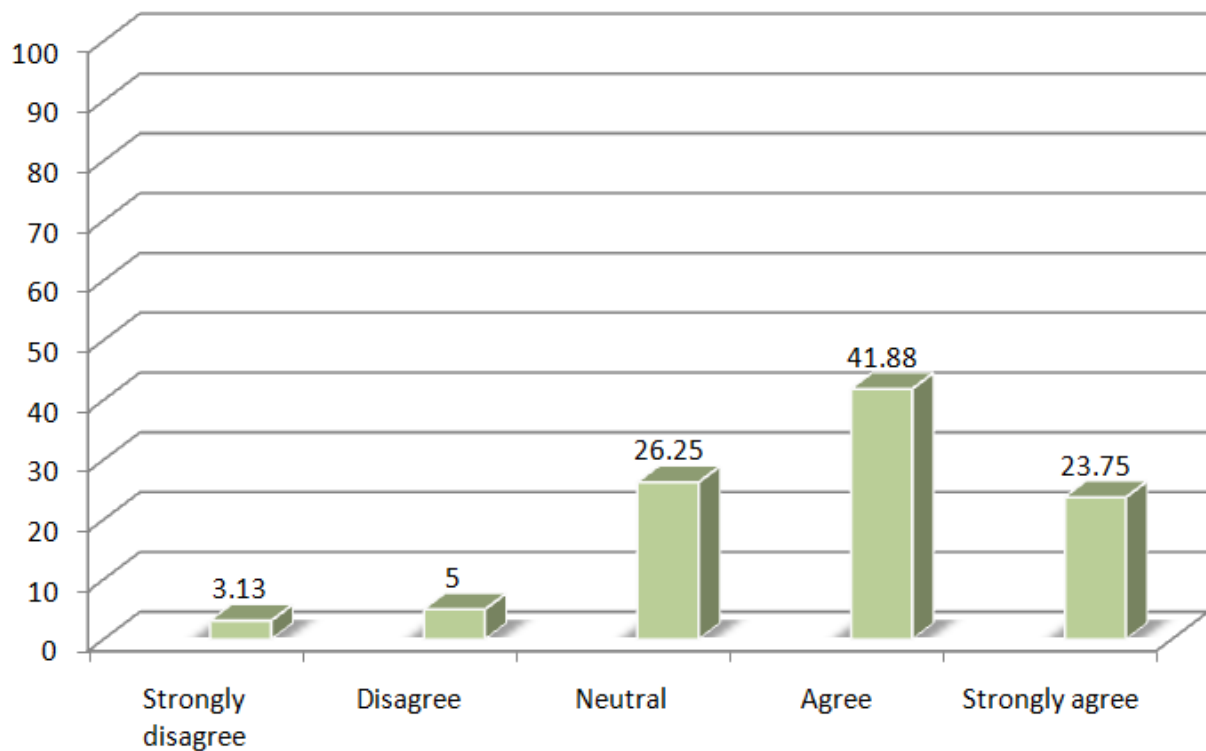
Overall, the data suggests that Bollywood has the potential to positively impact societal attitudes towards transgender individuals, but it needs to be done carefully and thoughtfully.

## CHAPTER 5

### 5. Conclusion:

The representation of transgender individuals in Bollywood films has undergone a significant transformation in the past decade. Earlier, they were portrayed as caricatures or as objects of ridicule, but the recent films have started to focus on their human experiences and struggles. There is a noticeable shift towards more nuanced and respectful depictions of transgender characters in Bollywood films.

Films like 'Chandigarh Kare Ashiqui' and 'Laxmii' (2020) have attempted to challenge the stereotypes and prejudices associated with the transgender community. These films have portrayed transgender individuals as complex and relatable characters, who have the same desires and emotions as anyone else.

Moreover, the casting of transgender actors in these films has also played a significant role in authentic representation. For instance, In the 2017 film Begum Jaan, transgender representation is present in the character of Rubina, played by actor Vivek Mushran. Rubina is a loyal friend and right-hand to the eponymous Begum Jaan, played by Vidya Balan. The film explores the struggles and discrimination faced by the transgender community in pre-partition India.

Rubina's character is portrayed with depth and sensitivity, and her gender identity is not used as a punchline or a gimmick. She is shown to be an integral part of Begum Jaan's group of women who run a brothel and refuse to give up their home when India and Pakistan are partitioned. The film portrays her character with empathy, and her portrayal is not overly sexualized or objectified.

Overall, while Rubina's character does not have a significant role in the film, her portrayal is an example of respectful transgender representation in Bollywood. In conclusion, while there is still a long way to go in terms of accurate representation and inclusivity, the recent films demonstrate that Bollywood is gradually moving towards a more empathetic and respectful portrayal of the transgender community.

There are some points which explain the overall conclusion of this research paper:

- Transgender individuals were previously depicted as caricatures or objects of ridicule in Bollywood films
- Recent films have attempted to challenge stereotypes and prejudices and focus on human experiences and struggles
- Nuanced and respectful depictions of transgender characters are becoming more prevalent in Bollywood
- Casting of transgender actors in these films is helping to break down barriers and stereotypes
- Bollywood still has a long way to go in terms of accurate representation and inclusivity, but the recent films demonstrate progress towards a more empathetic and respectful portrayal.

### 5.1 Limitations and Suggestions:

**Limited sample size:** Since the study is focused on a selective sample of films released in Bollywood between 2010 to 2020, the findings may not be representative of the entire population of Bollywood films that feature transgender characters.

**Limited scope of analysis:** The study focuses only on the portrayal of transgender characters in Bollywood films and does not take into account other forms of media representation, such as television or online streaming platforms.

**Limited access to primary sources:** The researchers may face challenges in accessing primary sources, such as interviews with filmmakers or actors, which can provide valuable insights into the creative process behind the portrayal of transgender characters in Bollywood films.

**Limitations of content analysis:** The study relies heavily on content analysis of the films, which may not capture the nuances of the portrayal of transgender characters in terms of context, tone, and intent.

**Lack of intersectional analysis:** The study does not account for the intersectionality of gender identity and other social categories such as class, caste, and religion, which can impact the representation of transgender characters in Bollywood films.

**Limitations of qualitative analysis:** The study relies on qualitative analysis of the films, which may be subject to researcher bias and interpretation. It may also lack statistical significance.

**Limited generalizability:** The findings of the study may not be generalizable to other cultural contexts or film industries outside of Bollywood.
